New Business

1. Join Online – Bob Yorburg

It was noted by the Treasurer Bill Guimes that PayPal is not integrated into the online membership process. You can fill in and submit the membership online and then not pay the dues. The website only gives you PayPal information. This needs to be addressed by the Webmaster Rich LeVangie. Agreed to leave discount for check versus fee for PayPal.

2. Donate Online - Bob Yorburg

This needs to be addressed by the Webmaster Rich LeVangie. Implementation is related to New Business Item 1. There was discussion on where membership receipts should go. There was discussion on whether the receipts were going to the Membership Committee or the Treasurer. All receipts should go to the Treasurer. The PayPal address and paper membership forms Treasure's address.

Needs to be addressed before rally season.

Stefan Batist and Spencer Meachum investigate this.

3. Rally Fees – Bob Yorburg

Attending members agreed that the Rally Fee was changed at a previous meeting from \$10 to \$15 but never updated on the signup forms. This was missed by multiple people who attended the board meetings. Need to enforce for 2025 season.

4. Rally Side Activities – Bob Yorburg

This is mainly the responsibility of the rally hosts. Information about the local area are good topics. The presentations are mainly for registered rally attendees, but everybody is welcome. Strive for more activities around rallies.

5. Finding new Presenters for The Wonders - Bob Yorburg

The was a plea by President Bob Yorburg to Board Members to find presenters for the monthly Zoom meeting. Need to encourage people with small collections to do videos. It was suggested that maybe we have a month dedicated to small collections and specifically solicit

for that. We did that last December and have it planned for July of this year. Stefan Batist has volunteered to host the Question-and-Answer session for those meetings, rather than having multiple hosts. Wally Venable suggested that we add short commercials to the meetings. They can be built and reused. There was even a suggestion to come up with a COAA jingle.

Spencer Meachum and Ian Fraser look to possibilities for this.

6. Forbidden Music – Bob Yorburg

It was decided that the editor's response published in the April 2024 journal was sufficient and no additional response was necessary. The two letters to the editor included in the agenda will not be published. They only present one side of the story. Editor Ron Bopp will notify the authors of the letters.

7. 100th Anniversary Journal - Ron Bopp

The President Bob Yorburg has already approved the extra pages. Recommends solicitating some full-page ads. Editor Ron Bopp has volunteered to cover additional beyond the eight pages.

8. Buffalo Heritage Carousel Collaboration – Ian Fraser

Ian Fraser said the Wurlitzer 153 at the Canal Side Carousel is now outside of the carousel which gives people more access to it. There are good crowds around it. The facility has some standardized plaques on some other displays but not on the organ. They need help to get words for the plaque to educate the public on the organ history and operation. President Bob Yorburg suggested we have a COAA advertisement plaque also. We also discussed having COAA applications available. Paul Senger suggested we have something more like an old-time poster for COAA and put a COAA QR code. This fits into the time period of the carousel, eliminates refreshing applications and makes it cheaper to mail. Plaques can get expensive. There is an opportunity to do this at multiple carousels (e.g. Glen Echo).

9. Review COAA Committee Assignments – Paul Senger

Discussed and resolved. Also acknowledged the now inactive 2024 Election Tally Committee 2024, Marie Beemish and Bob Stumer. Marie Beemish is now head of the Education Committee and responsible for *The Wonders of Mechanical Music & Carousels* operation.

Additional Discussions

Merchandise Online

Bob Yorburg brought up the idea of having COAA merchandise available on the COAA website. There are companies that can do imprints, embroidery and hot press on items and can set up a web section for an organization. There will probably be a startup cost to digitize the logo and select merchandise. Ron Bopp mentioned that Joan Haughawout prints tee shirts.

The question was brought up on who possesses the original COAA logo, which we would need to supply to the merchandise site. Bob also mentioned that at earlier meetings there were discussions on updating the logo to make it more printable with current technology. Dan Wilke's mother did the original logo.

Ron Bopp Circulate information on Joan's capabilities to Board. Ron Bopp and Spencer Meachum Investigate options.

COAA Facebook Access

Bill Hall noted that the board members can't make updates to the COAA Facebook page. Sam Harris needs to address this.

Contributions to The Wonders of Mechanical Music & Carousels Virtual Events

We have not received contributions from partners organizations to the operation of website and communications operations. Lady Liberty AMICA, The Musical Box Society International, MBSI East Coast Chapter, and National Carousel Association are our partners.

As the Virtual meeting attendance grows the organization is having trouble sending out too many e-mails and the web sites are asking for additional fees to move up to higher premium plans.

The treasurer has only received one contribution in 2022. As a non-profit we cannot invoice our partners. We can only ask for donations and suggest a value. We need to remind our partners.

Observations:

- 1. We had 310 memberships renewed. Almost all of these were households with two or more members per household.
- 2. Our rally season starts with a negative balance of \$350.00, as that is the cost of our liability insurance regardless of how many rallies we have. The East Broad Top Railroad Rally was not a financial success, as there was no sponsor for the Saturday night meal. Last year, our rallies generated \$802.00 in income. For 2023, not including the East Broad Top rally, our rallies generated \$600.23. Including the EBT Rally, our rallies lost \$143.81.
- 3. Rally Registration Fees: At one time it was \$20.00 per person. Then \$10.00. Many years ago someone proposed that rally registration be free, so as to attract more attendees. In talking with current rally attendees, the biggest consideration is the age of the attendees. The membership is getting older, and for some, traveling long distances is just not possible, especially when towing a trailer. The other factor is the cost of lodging.
- 4. All things considered, the dues increase was necessary. As far as I can tell, only one member did not renew his membership because of the dues increase.
- 5. About one third of the renewals are via PayPal, as are some donations. There is no longer any benefit to using PayPal Friends and Family. PayPal charges \$1.50 administration fee for the US members renewing with PayPal. The dues for international members is \$65.00

- a. Articles from the board - Again, I urge the <u>officers and board members to</u> <u>consider authoring an article</u> for the "Carousel Organ." Several have either done this or have something in the works.
- b. **Back issues - -** Gary Stevenson continues to do this quite well. Gary also spends a lot of time encouraging those who have not renewed their membership on a prompt basis to renew
